# 3. Matters Arising

a) Quinquennial Survey – Almost there! (Percy).

b) Following discussion at the North Beltisloe Group Council it was agreed that the appointment of officers for Safeguarding (child protection and vulnerable adults) and Health & Safety could be done on a group basis. However, for matters such as the testing of electrical equipment and fire extinguishers, some parishes had their own arrangements and it was left to the other parishes to make appropriate arrangements. It was agreed that we join with the Village Hall that already has a regular inspection schedule. (**Percy**)

c) A Lent course was successfully run in the village for the Group. It was decided to continue the meeting with a regular house group (3<sup>rd</sup> Thursday of the month) and details will go into the Group magazines and the website. (**Percy**)

# 4. Application for Grave Space

An application for grave spaces had been received from Mr & Mrs Burrows. This required the passing of a formal resolution; Mrs Collier had confirmed that there was adequate space in the churchyard to grant the request. Mr Exton proposed the resolution, seconded by Mrs Collier and passed unanimously by the meeting (copy attached). The graveyard plan (held in church safe) will be updated to show the reservation and a copy of this together with the application and all related paperwork will be sent to the Diocesan Registry. ### 5. Financial update

The audited 2010 accounts for the PCC and Friends of St Andrews had been presented at the AGM. The current balance of the PCC account is £3626.

We are hopeful of a positive response that will provide a regular income that will maintain the church and church life in Boothby Pagnell for future generations.
